To ensure that all stipulations of the contract are upheld, a credit card and non refundable deposit must be obtained to secure the event. Contract count is determined by seat/table usage, not by age. Menu selections and the final number of guests must be received by 7 days prior to the event date. Customer will be charged for any guests absent from the last agreed upon count. A 20% gratuity, 6% sales tax and 3% alcohol tax will be included in the total. Private room requires a \$1,000 minimum (before tax and gratuity), front room rental is a \$5,000 minimum (before tax and gratuity), and full buy out is a \$7,000 minimum (before tax and gratuity). Please adhere to our no glitter or confetti policy. If any is used in decorating, this contract is a binding agreement to a \$200 clean up fee.
